Lanier Volleyball Club 2024-25 Financial Agreement

Fees

- Your player fees cover Lanier Volleyball Club's (LVC) expenses for practices, training development, facility maintenance, equipment, coaches' compensation, tournament entry fees, USAV Membership fees, administrative expenses, administrative staff, uniforms and gear and other miscellaneous expenses incurred by the Club. Fees are billed either in full or over a span of several months per the agreed upon schedule. EXECUTION OF THIS AGREEMENT OBLIGATES THE PARENT/ GUARDIAN FOR THE FULL AMOUNT OF THE CLUB FEES, INCLUSIVE OF THE SRVA MEMBERSHIP FEE, IRRESPECTIVE IF, FOR WHATEVER REASON, THE PLAYER DOES NOT COMPLETE THE SEASON WITH LVC.
- Player fees for your team are shown in your League App Account 8 on the Commitment Night webpage. Club fees are collected either in full on commitment night or planned installments BY THE DATES SHOWN. Club fees do not include the cost of player or parent travel/related expenses, the uniform package or SRVA Membership costs.
- 3. Fees paid to the club are NON-REFUNDABLE.
- 4. PAYMENT OF ALL FEES ONLY PROVIDES THE PLAYER A "SPOT" ON THE TEAM. NO REPRESENTATION OR WARRANTY IS MADE BY THE CLUB CONCERNING PLAYING TIME, GUARANTEED POSITION, ETC. PLEASE REVIEW INFORMATION ABOUT PLAYING TIME IN THE PLAYER/ PARENT HANDBOOK.
- 5. Monies secured during fundraising will be reimbursed to the athlete up to the total amount paid for club player fees. Fundraising Monies will be applied to the last scheduled payment and work backwards towards any fees still due/ scheduled.

Payment Options

- The Online Payment System An execution and acceptance of a similar Financial Agreement with the payment schedule agreed to on the Online Payment System is available. This system allows for automatic ACH payments that incur no extra fees or automatic/manual Credit Card payments which do incur extra card fees. <u>This is</u> <u>Lanier's preferred and suggested method of payment for the 2024-25 Club Program</u> <u>Season.</u>

Please do not give any payments directly to a coach. Payments not made via the online payment system or may be mailed to the address above.

Failure to Comply

- 1. If on-time payment is not made as agreed upon as scheduled, a late fee of \$30 may be assessed and added to the account balance. Payments made after the 10th of the month are considered late and may not be accepted without the late penalty included in the check, cash or credit amount. If no payment has been made by the 15th day of the month, a phone call or email may be made to inform the responsible party that their athlete is placed on probation until the account is brought current. This probationary period serves as a warning that the player is in danger of being suspended from the club if the account is not brought current within 15 days of the given notice. The player's coach will be informed of the probation. If no payment is made by the end of the Probationary period a second phone call or email may be made to inform the responsible party that the player is suspended from the club. A suspended player may not participate in any team practices, training activities or tournaments. The player may remain on suspension until payment is brought current including late penalties and interest has been made and the payment has cleared the bank. If payment has not been made within 60 days of the due date, the account may be assessed a collection fee on top of all late fees and interest. The account may be turned over to a professional agency to assist in collecting what is still owed on this account. The player may be dismissed from the team.
- 2. Should any Parent/ Guardian not comply with the terms of this Financial Agreement, LVC reserves the right to pursue any member through legal proceedings and/or collection services for non-payment of fees owed to Lanier Volleyball Club, Inc. Such actions may result in adverse effects on the signing parties' credit scores and/or credit history. In addition, the expenses of the legal fees and collection agency incurred by LVC will be included.

Governance

This Financial Agreement will be governed by the laws of the State of Georgia. This Agreement constitutes the entire understanding of the parties regarding the subject matter of this Financial Agreement, and may only be modified or amended by WRITTEN SUPPLEMENT signed by both the Parent and Director.

By accepting this Agreement, I acknowledge and agree to the conditions set forth. I also agree that I am responsible for the full amount should my child choose or is not able to participate for any reason or should my child be suspended or dismissed as a result of a disciplinary action. Further, by signing this Agreement, as the Player's Parent/ Guardian, I confirm that I have read, understand, and agree to all the conditions of this Financial Agreement entered into with Lanier Volleyball Club, Inc.
